- **Plant Dibynol:** £228 y mis. Rhaid peidio â defnyddio'r ffigur hwn os nad oes gan ceisydd blant dibynol.
- **Costau Byw Cyffredinol:** £296 y mis. Rhaid peidio â defnyddio'r ffigur hwn os nad oes gan y Ceisydd gostau cartref misol.

## Changes to EX160A Court fees - Do you have to pay them?

On **1 May 2008**, the following changes will apply to EX160 Applications for Fee Remission;

### Concession 2:

Gross annual income limits have been increased. The new limits will come into effect on 1 May 2008 and are set out in the table below:

Number of Children	Total Gross Annual Income Limit <b>Single</b>	Total Joint Gross Annual Income Limit <b>Couple</b>
None	£12,000	£16,000
One	£14,735	£18,735
Two	£17,470	£21,470
Three	£20,205	£24,205
Four	£22,940	£26,940
Each Additional Child	£2,735	£2,735

### Concession 3:

Monthly fixed allowances have been increased. The new fixed allowances will come into effect on 1 May 2008 and are set out below:

- **Partner:** £150 per month. This figure must not be used if an applicant is single
- **Dependant Children:** £228 per month. This figure must not be used if the applicant has no dependant children.
- **General Living Expenses:** £296 per month. This figure must not be used if the applicant has no monthly housing cost.
